ELIGIBILITY – The applicant shall:

1. Be an American Citizen and a descendant of a confederate soldier.
2. Be a student in the senior class of an accredited high school.
3. Plan to use this scholarship award at an accredited Texas collage within one year of receipt.

APPLICATION PROCEDURE:

Each applicant shall submit with the application, the following:

1. Essay of 50 words or less stating why you feel you should receive the scholarship
2. A completed lineage chart.
3. Transcript of grades sent from the school with a minimum of a 3.0 GPA.
4. Return assembled material to the High School Guidance Office by their deadline.
5. Deadline for return of application to Lamar Fontaine Chapter #33 is February 1, 2022. Please call 979-345-5767 to have application picked- up or mail to Jimmie Bennett, #10 Evergreen Lane, West Columbia, Texas 77486.

SCHOLARSHIP REGULATION

1. The \$500.00 scholarship is a non-liquid award payable only to the college in August. The student must maintain a minimum of 12 hours enrollment and 3.0 GPA.
2. Should the student fail to enroll or leave the college or university, any unused portion of the Scholarship shall be returned to the Lamar Fontaine Chapter #33.
3. Winner of this Scholarship may qualify for numerous additional UDC Scholarships for multiple years and graduate degrees. Additional information and wallet size photo will be required for national level competition for scholarships.
